- ✓ RSVP on Moving Wisconsin Forward to Rachel Schendel at RVEP
- ✓ Remember to call Personnel if you have a spouse that needs to be added to insurance. If you are newly married, you have 30 days to enroll. If your spouse experiences a job loss, job change, etc. and needs to sign up for insurance, they have to enroll within 30 days of the change. There is a 1 year waiting period **if you forget to sign up within the 30 days** so then you would need to sign up and wait for the year from the sign up date. For a new/adopted child, you have 60 days to enroll them for insurance coverage. There is a 1 year waiting period for children if you miss the 60 day deadline.
