Public Hearing | Saturday, January 23, 2:00 pm to 5:00 pm | Kolak Education Center

The Board of Education is hosting a Public Hearing on Saturday, January 23. You will be provided three minutes to speak to the Board of Education and share your thoughts on resuming in-person athletics and extracurriculars.

The Board of Education will follow the social distancing guidelines set forth by the Rock County Health Department, and room capacity for this event is 51 people. Once room capacity is met, the Board of Education will not allow any more people to enter the Kolak Education Center. All individuals wanting to make a public comment will be able to do so.

Public Comments:

In-Person: Those who wish to speak in person, must complete a public comment card upon arriving at the Kolak Education Center. Each speaker will have three minutes to speak. Speakers will be required to wear a face covering while they are speaking and while they are in the Kolak Education Center. If the Public Hearing is at room capacity, speakers will be asked to exit after speaking.

Email: Those who wish to email their public comment may do so by emailing public-comment@sdb.k12.wi.us and your comment will be read publicly. If you wish to share your comments with the Board of Education, but not have your comment read publicly, you can reach out to the members of the Board of Education through their email address: [LINK](#)

Phone-In: Those who wish to phone-in and provide a public comment, should do so during the hours of 2:00 pm and 5:00 pm on Saturday, January 23. Please call this number: 1-708-607-2760, you will be prompted to enter this pin number: 196914802#. Please stay on the line until Michelle Shope admits you to the Public Hearing to share your comment.

Attending the Public Hearing:

Anyone attending the Public Hearing will be required to complete a COVID-19 screener that will be available through a QR Code and through a paper form at the entrance of the Kolak Education Center. Face coverings will be required for anyone entering the building and must be worn for the duration of the meeting.

It is important to stay home if you are not feeling well. COVID-19 symptoms include cough, shortness of breath or difficulty breathing, new loss of taste and/or smell, or two of the following symptoms: fever and/or chills, fatigue, muscle or body aches, congestion or runny nose, sore throat, headache, nausea or vomiting, or diarrhea.



Please stay home, if you have had contact with anyone suspected/diagnosed with COVID-19, or if someone in your household has been diagnosed with COVID-19 in the past 14 days. You can always share your comments through email and by phoning in.

Spanish Interpreters:

Spanish interpreters will be available during the Public Hearing. You will be given six minutes to speak if you need interpretation.
