REGULAR MEETING OF THE BOARD OF EDUCATION SCHOOL DISTRICT OF BELOIT April 28, 2015

The Board of Education held its regular meeting on April 28, 2015 at the Kolak Education Center in the Board Room. President Scharmer called the meeting to order at 7:25p.m.

Members Present: John Acomb, Lisa Anderson-Levy, Dennis Baskin, Nora Gard, Shannon Scharmer and John Winkelmann. Member excused: Michael Ramsdail. Also present: Tom Johnson, Interim Superintendent.

Winkelmann moved approval of the agenda. Seconded by Acomb. Motion carried unanimously of the members present. Acomb led the group in the pledge of allegiance and gave the announcements for April.

Melissa Badger, along with Shawn Pettit, Cunningham Educator, recognized the students in his class who promoted PBIS character traits through videos made on their iPads. She also recognized, along with Dick Vogel and Kim Wait, Coaches, the Purple Tide swimmers who not only are great athletes, but also outstanding academic students. Badger then recognized outstanding staff members with the assistance of their building principals from Morgan, Robinson, Todd, and McNeel. She recognized Tammy Flanders who was instrumental in conducting the Wisconsin Asthma Coalition (WAC) school walkthrough program in the district. Seconded by Acomb. Motion carried unanimously of the members present.

Winkelmann moved approval of the revisions of Policy 343.7 District Online Learning for final reading. Seconded by Acomb. Motion carried unanimously of the members present.

Winkelmann moved approval of the revisions of Policy 443.2 Student Conduct on School Buses for final reading. Seconded by Acomb. Motion carried unanimously of the members present.

Winkelmann moved approval of the revised personnel recommendations. Seconded by Acomb. Johnson recognized the years of service of retirees and the new Assistant Principal hires for Aldrich and Fruzen. Motion carried unanimously of the members present.

Items for future meetings included a report on the privatization of the maintenance/service staff and a five year report of expulsions.
